Kelly Simpson

Demographics	See computer. Resembles Rachel Kennelly (RK).
Method/Manner of Death	Manual Strangulation. The bridge stunt implied suicide, and then drowning. The time in the salty water messed up the time of death calculations, and any forensic data that might have been left.
Manner of Disposal/Recovery	<p>Manipulative and Deceptive</p> <ul style="list-style-type: none"> • Her car was left on Sunshine Skyway- why? To indicate suicide in case the body was never found? To blame RK? • Business Card taped to dash- why? It pulls RK into the investigation. If the killer is not implying it's her fault, then he wants her attention for some other reason. The card screams 'look at me' and it feels like attention getting to me, but RK must be cleared. • How did the killer get away from the crime scene? An accomplice seems unlikely. Bicycle in trunk with detachable front wheel is more likely. Bik oil found in trunk. No one saw a bike rider- but then a man dressed in dark clothes on a black bike would not be noticed. Not picked up on street cameras/ Just extremely happy or does he know where they are? • Was she weighed down and not supposed to come up and drift? Medical Examiner (ME) can't rule it out. • Actual murder site is her apartment. Why? Because it's meticulous and her mother says she wasn't. Dishes and laundry were washed and dried. Floor vacuumed. Garbage nd vacuum bags missing. No garbage from apartment found in any dumpsters for a two-block radius on every side. • Last seen by neighbor Friday, April 26, around 9:30, and at midnight didn't answer her texts. Waitress at The Keg confirmed her last meal on Friday at 6:00 PM. No one saw anyone with her. Left in her car alone.
Working Hypothesis of the Crime	Unknown killer strangled her in her apartment and did a very effective cover-up that draws attention to RK. RK is deeply involved whether she knows it or not.
First Line Suspects	<p>None</p> <ul style="list-style-type: none"> • RK is the person we need to question extensively. • Interview men who knew her, especially neighbors and The Keg. Check female neighbors and and camera recordings for anyone who was near the apartment Friday-Sunday.

Connie Gordon

Demographics	Due to condition of body, taken from DMV and ME reports. Resembled RK.
Method/Manner of Death	Broken Neck. Body was burned in an accelerant fire.
Manner of Disposal/Recovery	<p>Manipulative and Deceptive.</p> <ul style="list-style-type: none"> • Burning the body after dropping the body in water ... purified by fire? Baptism? There's a theme here somewhere. • Purse left and RK business card stapled to tree in front yard. Again, very 'in your face'. • CG worked for RK until three weeks prior to death. Fired for theft. She confessed by coming back later to sell the earrings back to RK- who didn't pay her. Also offered them to Jackson Kennelly (JK), who uses her as an unregistered snitch and perhaps occasional sex partner. • The purse and card leave little doubt it's the same killer with the same issues which revolve around RK. In this case, we know the decedent did actual harm to RK, whereas KS only failed to get better and whined about her treatment. Will the next one be a complete enemy of RK? • Additionally, the lack of forensic data is also a signature that identifies the killer. • Fire started May 20th between 3:00-3:15 am. Unknown caller to 9-1-1, couldn't be traced. Time of Connie's death was up to twelve hours earlier. • "See me?", "Watch me, Mommy!" Attention-seeking. Like a cat who drops a dead mouse at your feet. I feel that these murders are 'gifts' to Rachel and her card is the gift tag.
Working Hypothesis of the Crime	<p>I have no doubt that an experienced serial killer is in town and is infatuated with RK.</p> <ul style="list-style-type: none"> • The same unknown killer broke her neck, which I'm told takes a significant amount of strength and rage. Not a female killer. The motive must be the same, even if some elements appear to be different. Ignore the differences and look for what's the same. • CG was not seen with anyone specific on 5/20 but was at The Keg earlier in the evening. That bar is connected, but RK has never been there.
First Line Suspects	<p>None</p> <ul style="list-style-type: none"> • Interview Jackson Kennelly. He is capable of copycat murder and would know the holdback. If it's him, he would have to use the card to be consistent, not because he wants to implicate RK. • We need to crawl inside that bar, investigate every occupant and patron, and look at camera feeds on the street between there and the residences.

Darlene Williams

Demographics	Due to the condition of the body, DMV and ME Report used. Strongly Resembled RK.
Method/Manner of Death	Victim was badly beaten with fists and a hold back item Many potentially fatal injuries, but in the end, cause of death was strangulation. This woman suffered and did not die gently. Everything about the crime scene screams 'rage'.
Manner of Disposal/Recovery	Not manipulative at all. Body was posed, naked, to be seen as soon as the apartment door opened in a sexualized manner, with a holdback item inserted in her vagina. We wondered where the card was and the ME found it stuffed down her esophagus, and written in black Sharpie on the back were the words, "Hi Bart!". This murder doesn't feel like a gift. That was an act of anger and defiance. RK has disappointed him after seeing her on our staged date with Miller.
Working Hypothesis of the Crime	Uncertain: This could be the escalation of a serial killer who is not being 'heard' or the work of a man with a hatred for the victim. The victim is Jackson Kennelly's new girlfriend, who reportedly hates RK and has been vary vocal about it. The fact that she looks like RK is likely a source of hatred. Victim fits the 'gift' profile of killing problems for Rachel, but the escalation and display of rage make the motivations unclear. This killer is losing his ability to control his impulses.
First Line Suspects	Must clear Jackson Kennelly!

Jennifer Bradley

Demographics	Jennifer could be mistaken for RK easily. This is more than a resemblance. And she's RK's best friend.
Method/Manner of Death	She was tied in a complicated pulley and rope combination that didn't allow her to either fully bend or fully straighten her legs. She was raped orally, vaginally, and anally. Jennifer may have strangled herself to escape the killer's final gutting. When he got out the knife she may have given up, or she may have died from shock. There was blood on scene so her heart was pumping when he started to cut, but ME thinks she was unconscious for the worst of it. Please see the autopsy report for the complete details.
Manner of Disposal/Recovery	There was a delay in finding her body because her husband and son were camping. Not sure if the killer knew that.

Working Hypothesis of the Crime	She was killed to punish RK for her staged date- but it was within hours of him killing Darlene- so there must be a secondary motivation. The frame someone?
First Line Suspects	<ul style="list-style-type: none">• It defies logic to think Jackson is evil enough to kill Darlene and Jennifer within hours of each other• UNSUB who is paying back RK, framing Jackson, escaping the FBI, and rubbing it all in Miller's face?• Ben Montgomery, James Kincaid, and Jackson were all alive when Jennifer was killed
